VIII. QUALIFYING DATES

The qualifying dates for the General Primary Election are March 4th- March 8th, 2024. Non-Partisan candidates qualify in the election office 8:30 a.m.- 5:00 p.m. daily except on Friday, March 8th, 2024 the hours are 8:30 a.m.- 12:00 p.m. Qualifying fees have been posted on the election website, newspaper and a notice on the front door.

The City of Andersonville is having a special election on May 21, 2024.
