

# Sumter County Board of Elections Meeting January 4, 2022 at 4:30 pm

## **I. Call to Order**

The meeting was called to order by Vice Chairman Dr. Shirley Latimore at 4:33 pm.

## **II. Roll Call**

## **III. Election of New Officers for 2022**

Mr. Howard gave Dr. Roberts a warm welcome and informed the board she had been sworn in by Judge Stephanie Bennet around 3:30 p.m., therefore, she was an official board member. He stated this is a new year, and therefore new officers were to be elected. A chairperson, co-chairperson and secretary was up for election.

## **VIII. County Commissioner District #3 Special Election, March 15, 2022.**

Mr. Howard advised there are possibly 4 or 5 persons to be qualifying for this seat beginning Monday, January 10, thru Wednesday, January 12, 2022 at 12:00 noon. As soon as he gets the paperwork in order, he will be sending it up to the State for approval, and then ballots will be ordered.
